Admission of students in affiliated institutions (Point No. 11 of Norms)

All the students admitted in the affiliated institutions shall register themselves with the College of Veterinary Sciences, LUVAS, Hisar after paying the prescribed registration fee (which will include academic examination and other annual charges, incidental thereof) each year as per schedule prescribed by the college.

The representatives of concerned Institutes will have to present themselves at the time of counseling for their Institute for 50% of the seats to be filled by the LUVAS at LUVAS, Campus. Similarly two representatives of Director, Institute of Para Veterinary Sciences to be decided in consultation with Dean, COVS will be present in the concerned Institute on the day of counseling for admission of 50 % seats of their management quota.

All the students admitted in the affiliated institutions shall register themselves with the College of Veterinary Sciences, LUVAS, Hisar after paying the prescribed registration fee (which will include academic examination and other annual charges, incidental charges thereof) each year as per schedule prescribed by the college.

The representatives of concerned Institutes will have to present themselves at the time of counseling for their Institute for 50% of the seats to be filled by the LUVAS at LUVAS Campus. Similarly two representatives of Director, Institute of Para Veterinary Sciences to be decided in consultation with Dean, COVS will be present on the day of counseling for admission of 50 % seats of their management quota. The counseling for management quota seats for the private institutions will be held at LUVAS, Hisar Campus.

Admission process for the Academic Session 2017-18 (Point No. 13 of Norms)

Existing

The admission process for the diploma course must be completed before 30th September of each academic year and no admission will take place after this date. The academic calendar as prescribed by the Director, IPVS, LUVAS, Hisar and instructions/clarifications on it issued by the University shall be followed by the affiliated institutions.

The admission process for the diploma course must be completed before October 30, 2017 for the Academic Session 2017-18 and no admission will take place after this date. The academic calendar as prescribed by the Director, IPVS, LUVAS, Hisar and instructions/clarifications on it issued by the University shall be followed by the affiliated institutions.
